**ORDER**

Whereas this office has received a request dated 17.12.2024 from Ex-President of Haryana Environmental Management Society (HEMS) SCO-45, 1<sup>st</sup> floor Sector-31, HUDA Market Gurugram regarding compiling the order of Hon'ble Civil Judge, Gurugram in CS No. 3787/2024 (Shri Ram Pratap Gupta Verse Haryana Environmental Management Society, Gurugram (Haryana)).

In this regard it is intimated that the election of the above said society was conducted on dated 12.12.2022 under the provisions mentioned in the Bye Laws of the said society for the period of Two years i.e. 12.12.2022 to 11.12.2024.

Thereafter the Bye Laws of the said society has been amended vide which the term of the Governing was increased from two years to three years and the same has been approved on dated 10.01.2024 by this office and it will commence from next election. As the tenure of Governing Body of the society i.e. Haryana Environmental Management Society (HEMS) has already expired on 11/12/2024 according to the old Bye-laws of the said society and at present there is no one to look after the affairs of association and under such circumstances Administrator is necessary to be appointed to manage day to day affair in the society.

Hence, in the view of above by exercising powers conferred u/s 39 (10) of the HRRS act, 2012, I hereby appoint Sh. P.K. Bansal Additional Director (Retd.) of Industries & Commerce, Haryana as Administrator-cum- Returning Officer to manage the day to day affairs and to conduct the election of the Governing Body of the (HEMS) Society, at SCO-45, 1<sup>st</sup> floor Sector-31, HUDA Gurugram as per the provisions of HRRS Act/Rules, 2012 as well as bye-laws of the association for a period of 3 months or till new Governing Body whichever is earlier.

The Administrator-cum-Returning Officer is directed to manage the day to day affairs and complete the election process of the association within the stipulated period strictly adhering to the Bye laws of association and under the provisions of HRRS Act/Rules, 2012. He shall be paid remuneration as per provisions contained in the HRRS Act, 2012 and shall be paid from accounts of the association and further directed to complete the process of election under videography and submit a report thereof. A copy of the guidelines dated 04.05.2022 issued by the Govt. is enclosed herewith.
